

**OPERATING PLAN FOR DOMESTIC VIOLENCE MISDEMEANOR
AND CCC CASES BETWEEN MARCH 16th and APRIL 30th, 2020**

Appearances: Counsel, Pretrial, and CSOSA may appear by telephone by emailing chambers in advance. All DVM and CCC cases will be heard in Courtroom 118.

DVD Clerk's Office: The clerk's office will be available remotely for inquiries.

DVM Arraignments and Detention Hearings will proceed as scheduled. Cases will not be heard in Courtroom 119. DVM arraignments will take place in Courtroom C10. CCC arraignments will be continued to a date after May 1st, 2020. DVM and CCC detention hearings will take place in Courtroom 115.

Pretrial and Probation Show Cause Hearings will proceed as scheduled, unless the parties are notified otherwise by the court.

Bench warrant returns in DVM and CCC cases will take place in Courtroom 118 until further notice.

Mental Observation Hearings

- Detained Defendants (D.C. Jail and St. E's): All MO hearings will proceed as scheduled. The court may inquire whether defense counsel plans to waive a defendant's presence.
- Non-Detained Defendants: All MO hearings shall be continued to the date set forth in the attached schedule, unless either party requests an earlier hearing.

Hearings in DVM cases (Status, Sentencing, DSA Review)

- Detained Defendants: All hearings for detained defendants will proceed as scheduled, absent a motion to continue being filed. Parties can appear by telephone by emailing chambers in advance. Defendants held on a nominal bond and/or held other charges, other than on a parole warrant, shall be treated consistent with detained defendants.
- Non-Detained Defendants: All hearings for non-detained defendants scheduled before May 1st, 2020, shall be continued to the date set forth in the attached schedule, unless either party requests an earlier date. Any current orders, including stay-away orders, will remain in effect until the next court date.

Misdemeanor Non-Jury Trials:

- Detained Defendants: All non-jury trials set on the DVM calendars for detained defendants between March 16th and March 27th will be converted to a status hearing on the original trial date for purpose of selecting a new trial date. All non-jury trials set after March 27th will proceed as scheduled, absent a motion to continue being filed or further extension of time as ordered by the Chief Judge. Defendants held on a nominal bond and/or held other charges, other than on a parole warrant, shall be treated consistent with detained defendants.
- Non-Detained Defendants: All non-detained trials shall be continued to the date set forth in the attached schedule, unless either party requests that the case receive priority status by filing a motion with the Presiding Judge or her designee at least one week prior to the originally scheduled trial date.
